A. Section 21.1 is hereby amended to read:

Except in cases of amendments that may be executed by a Declarant (in the exercise of any Development Right), the Association (in connection with Sections 4.3 or 7.2.3, Articles 15 or 20, or termination of the Condominium), or certain Unit Owners (in connection with Article 4 or 7.2.3 or Article 20, or termination of the Condominium), and except as limited by Section 21.4, the Declaration, including the Survey Map and Plans, may be amended by vote or written agreement of Owners of Units to which at least sixty-seven percent (67%) of the votes in the Association are allocated.

B. This Amendment to the Declaration shall take effect upon recording. The terms of this Amendment to the Declaration shall control over and implicitly amend any inconsistent provision of the Declaration or the Bylaws or Rules and Regulations of the Association. Except as amended by this instrument, the Declaration shall remain in full force and effect.
